VIII of General Information & instructions of the advertisement, "In case the marks are obtained in the form of GPA/CGPA/OGPA etc, a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form", the candidate was required to submit CGPA conversion certificate, but it is found that candidate has not submitted CGPA conversion certificate with the application form. 2.The candidate has passed MPH on dtd. 15.05.2019. As per the submitted documents, the total period of experience at PTCTU, SOA University as Research Assistant from 10-10-2019 to 12-02-2020 (4 Months 3 days) & as Research Associate From 1-9-2020 to 28-2-2021 (5 Months 28 days) is only 10 months, which is less than requisite 03 years of post-qualification experience. 3. As per the point no. vii of General Information and instructions of the advertisement, "The experience certificate of the Employer/s must clearly specify the period of incumbency, name of the post and nature of responsibility", hence, the offer letter of Care India and the recognition Letter of Covidence can not be considered as experience certificate. So, the application is rejected as per the terms & conditions of the advertisement.
