The Second experience column I mentioned is that I completed my master's in public health (MPH) in June 2017 and my last semester exam was conducted on 1st May 2017. After the examination, I joined a project on 30th May 2017 and continued till 1st June 2018. This tenure accounts for an accumulated experience of 1 year. I attached a self-attested photocopy of my experience details with the submitted application form. My Overall experience is 5 years and 11 months. However, on the application selection list, my total experience was calculated as 2 years. Please I kindly request review my details one more time. | The application form has been verified again. As per the advertisement "the candidate must have minimum 05 (five) years of experience in health sector". 1. As per the Point No. Vii of General Information & Instructions of the advertisement, "the candidate has to exhibit requisite documents / experience certificates which shall clearly establish his/her eligibility as per conditions as above, without which his/her candidature shall be rejected. The experience certificate of the Employer/s must clearly specify the period of incumbency, name of the post and nature of responsibility." 2. From the submitted experience certificate of ICMR-RMRC as Project Assistant, Bhubaneswar, though the date of joining has mentioned but the date of continuance at RMRC has not mentioned. So, the working period of experience could not be ascertained from the submitted document. Hence, the same can not be considered. 3. As per the submitted experience certificate of AIPH as Research Assistant, the period of experience from 30.05.2017 to 01.06.2018 is only 1 year which is less than 5 years of experience as per the advertisement. Hence, the application is rejected as per the terms and conditions of the advertisement. |

The experience certificate of the Employer/s must clearly specify the period of incumbency, name of the post and nature of responsibility." 2. The experience certificate of Mission Shakti as Block Project Assistant-cum-Accountant can't be considered as health sector experience and also the working period of experience could not be ascertained as the date of joining has mentioned but the date of continuance has not mentioned. Hence, the same can not be considered. 3. As per the submitted experience certificate of DPMU (NHM), Sambalpur as Data Assistant-cum-Accountant, NUHM from the period of 26.12.2016 to 14.03.2018 is only 1 year 2 months 17 days. 4. the experience at Ziquiza Healthcare Ltd. Bhubaneswar as Accounts Assistant from 05.01.2015 to 15.12.2016 is 1 year 11 months 11 days. The total period of experience is 3 years 1 month 28 days which is less than 5 years of experience as per the advertisement. Hence, the application is rejected as per the terms and conditions of the advertisement. |
