- v. Candidates will be selected on the basis of selection process as applicable. Only shortlisted candidates will be called for participation in the selection process.

Candidates, who are already working in Health Department/ Govt. sector either on regular or on contractual basis, have to submit **No Objection Certificate (NOC)** from the employer (appointing authority) at the time of submission of application. Certification towards AICTE/UGC recognition of Institutions/Universities shall also be submitted at the time of submission of application from, wherever applicable, without which the application shall not be considered & shall be rejected.
- ix. Over aged, under qualification & lack of post qualification experience shall be rejected.
- x. The candidates securing 50% and more marks in interview shall be kept in the Panel with the validity of 01 year from the date of its approval for similar post with same eligibility criteria and same remuneration, as will be decided by the Society.
